

**FRATERNAL ORDER OF POLICE LODGE #86  
WAYS AND MEANS COMMITTEE  
2018 OFFICIAL RAFFLE RULES**

**1. THE RAFFLE**

These Official Raffle Rules apply to the "2018 Fraternal Order of Police Lodge #86 Ways and Means Committee Raffle" (the Raffle). The Sponsor is the Fraternal Order of Police Lodge #86, a State of Florida non-profit, fraternal organization operating for the benefit of its members. The proceeds will benefit fallen or injured officers and their families. The Promotion Period begins on 8-30-2018 at 12:00 AM and ends on 11-1-2018 at 6:30 PM.

By participating in the Raffle, each entrant unconditionally accepts and agrees to comply with and abide by these Official Raffle Rules and the decisions of the Sponsor, which shall be final and binding in all respects. The Sponsor is responsible for the collection, submission, and processing of entries, as well as the overall administration of the Raffle. Entrants should look solely to the Sponsor with any questions, comments, or problems related to the Raffle. The Sponsor may be reached by email at [Board@FOP86.com](mailto:Board@FOP86.com) during the Promotion Period.

The Raffle is subject to all applicable Federal, State, and local laws and regulations.

**2. TICKET/ODDS**

There is no purchase necessary to enter or win a prize. Making a purchase or payment of any kind will not increase the chances of winning a prize. The chances of winning a prize will depend on the number of tickets ultimately distributed. There is no limit on the number of tickets which may be purchased by any individual. A winning ticket will not be returned to the drawing pool for a chance to win another prize; one chance to win per ticket.

**3. ELIGIBILITY**

The Raffle is open to legal residents of the State of Florida and all other states in the United States, except as may be prohibited by law. Raffle entrants must be at least 21 years of age at the time of the Raffle drawing.

**4. THE PRIZES**

There are three (3) prizes which will be drawn in the following order:

- 3rd Prize – \$150 VISA Gift Card
- 2nd Prize – \$250 VISA Gift Card
- 1st Prize – One (1) Kel-Tec Sub-2000 Semi-Auto Rifle (approximate retail value \$500)

Only one prize per person per household will be awarded. A household shall mean those people who share the same residence at least three months a year.

Prizes cannot be transferred, redeemed for cash, or substituted by a winner. If a prize described in these Official Raffle Rules is unavailable or cannot be awarded, in whole or in part, for any reason, the Sponsor reserves the right, in its sole and absolute discretion, to award a substitute prize of equal or greater value. The decision of the Sponsor or its designee is final, and the prizes must be accepted as awarded. Should a prize winner be unable to claim an awarded prize, his or her prize will be forfeited.

The 1st Prize Winner will be issued a voucher for the awarded firearm. The voucher can be used to purchase the awarded firearm, or a gift card will be issued. The 1st Prize Winner must pass all applicable background checks to obtain the firearm. If the 1st Prize Winner fails the background check, he or she may still use the gift card for merchandise

other than firearms.

Gift cards are subject to the terms and conditions of the issuer.

The approximate retail value of the prizes ranges from \$150 to \$500. Actual prize values are subject to slight market changes. The actual prize values will be confirmed prior to the drawing. If the actual value of the prize turns out to be less than the stated approximate retail value, the difference will not be awarded.

Raffle winners are solely responsible for any and all taxes, surcharges, or additional fees that become due with respect to the prize. The value of the prize may be taxable as income – please consult your own tax advisor.

The Sponsor makes no representation or warranty concerning the appearance, quality, safety, fitness, or performance of any prize awarded. Every entrant understands and acknowledges that he or she may not seek reimbursement or pursue any legal or equitable remedy from the Sponsor or the prize providers should the prize fail to be fit for its purpose or is in any way unsatisfactory to a prize winner.

Restrictions, conditions, and limitations may apply.

The Sponsor will not replace any lost or stolen prize items.

Failure to comply with the Official Raffle Rules will result in forfeiture of the prize.

## **5. HOW TO ENTER**

Enter the Raffle during the Promotion Period by visiting a designated ticket seller and completing a raffle ticket in its entirety. Incomplete or illegible tickets will be voided.

## **6. RAFFLE DRAWING**

The winners of the Raffle will be selected in a random drawing from among all eligible entries received throughout the Promotion Period. No further entries will be accepted beyond that date and time, and will be considered null and void if received after that point. Entrants need not be present to win. The Raffle drawing will be conducted by the Sponsor or its designated representatives at approximately 7:00 PM on 11-1-2018 at the Fraternal Order of Police Lodge #25, 5505 Hansel Ave., Orlando, FL 32809.

Each Raffle winner will be notified by telephone approximately 1 day after the drawing at the telephone number provided on the winner's entry, unless the winner is present at the Raffle drawing. Within 48 hours after the Sponsor or its designee has notified the Raffle winner, the winner must contact the Sponsor or its designee via telephone, and accept his or her prize as directed by the Sponsor or its designee. If a winner fails to properly contact and accept his or her prize within 48 hours as directed by the Sponsor or its designee, the prize may be considered forfeited. The Sponsor is not responsible for any delays or failure by the winner to accept a prize for any reason, including inactive phone account(s), technical difficulties, or a winner's failure to adequately monitor any phone account.

## **7. CONDITIONS OF ACCEPTANCE**

Before being awarded any of the prizes, the prize winners must, within thirty (30) calendar days from the Raffle drawing:

- a) Show valid photographic government issued identification to the Sponsor's designee.
- b) Accept transfer of the prize within thirty (30) calendar days from the date of the Raffle drawing
- c) Sign all documents deemed necessary in the Sponsor's sole discretion, including but not limited to:

(i) A Release of Liability, acknowledging and agreeing that the prize winner releases the Sponsor and prize provider(s), and all of their directors, managers, officers, employees, and agents (collectively the "Releases") from any and all liability arising in connection with participation in the Raffle and acceptance of the prize.

(ii) A Prize Acceptance Agreement to accept the prize and to be responsible for all associated costs with redeeming the prize.

(iii) A Promotional Release authorizing the use of the prize winner's name and likeness by the Sponsor for marketing, advertising and promotional purposes.

(iv) A Release stating that the prize winner will abide by all the Official Raffle Rules.

In the event a prize winner is unwilling or fails to provide any of the foregoing for any reason, the Sponsor may, in its sole and absolute discretion, disqualify the prize winner and consider the prize forfeited.

## **8. PRIVACY POLICY AND SOCIAL NETWORK DISCLAIMER**

By entering the Raffle and voluntarily providing personal information, (including but not limited to your name, address, city, and home phone number), each Raffle entrant grants permission to the Sponsor to collect and use the entrant's information for the exclusive purpose of administering the Raffle and selecting the prize winners. Unless the entrant agrees otherwise, no correspondence will take place between the Sponsor and the entrants except in connection with participating in the Raffle and, in the case of a prize winner, winning a Raffle prize. Any personal information supplied by you will be subject to the privacy policy of the Sponsor. By entering the Raffle, you grant the Sponsor permission to share your name and other personally identifiable information on a publicly available prize winners list.

The Fraternal Order of Police Lodge #86 reserves the right to post winners on social media platforms monitored or administered by the Public Information Officer or designee. Entrants not wanting their information posted on social media must make a request in writing prior to the 11-1-2018 drawing via email to [Board@FOP86.com](mailto:Board@FOP86.com).

## **9. LIMITATIONS OF LIABILITY**

The Sponsor assumes no responsibility or liability for (a) any incorrect or inaccurate entry information, or for any faulty or failed electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Raffle; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, camera, computers or providers utilized in any aspect of the operation of the Raffle; (d) inaccessibility or unavailability of any network or wireless service, the Internet or website or any combination thereof; (e) suspended or discontinued Internet, wireless or landline phone service; or (f) any injury or damage to a participant's or to any other person's computer or mobile device which may be related to or resulting from any attempt to participate in the Raffle or download of any materials in the Raffle.

If, for any reason, the Raffle is not capable of running as planned for reasons which may include, without limitation, infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes which may corrupt or affect the administration, security, fairness, integrity or proper conduct of this Raffle, the Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify, or suspend the Raffle, in whole or in part. In such event, the Sponsor shall immediately suspend all drawings and prize awards, and the Sponsor reserves the right to award any remaining prizes (up to the total approximate retail value as set forth in these Official Raffle Rules) in a manner deemed fair and equitable by the Sponsor. The Sponsor and the Releases shall not have any further liability to any participant in connection with the Raffle.
